Benjamin Nez, Chapter Vice President: He reported update statues on the temporary chapter building and donated modular building for Coalmine Canyon Chapter. On April 1, 2021, Alicia Chee, Mr. Dayzie and myself did a site visit to Coalmine Canyon Chapter to where the donated doublewide trailer will be going. Mr. Dayzie the contractor, he will be moving the doublewide to the site location, put the skirting back on, compacting the ground, leveling it and putting up a temporary fence around the doublewide until the permeant fence is put up. He will also be moving the old backhoe out of the way.

Harry Goldtooth, Grazing Official: All 15 water tanks have water in them. There are funds available for grazing holder's permittees, funding to \$30,792.47, add a resolution. Some people are still hauling water and buying hay for livestock. For livestock permit holders with no tally counts, overgrazing and/or permits that are in dispute will not get hay, salt or mineral block.

Thomas Walker - Spring Session is coming up in April for the Council Delegates. There are upcoming work sessions coming up for the Council. Walker reported the chapter is receiving a double wide trailer, he asked for excess building existed approximately 2 years ago and requested if any to re purpose if any buildings. President Nez and Speaker Chaco supported the initiative of receiving the buildings and transferred to Coalmine Canyon Chapter. Reported on upcoming plans for the modular building and later point of express appreciation to all involved parties. There are tasks that needs to be done, protection, security, parking lot and connection to the modular building. He mentioned American Rescue Plan Act, for short ARPA, (2.5 years) it's still in the draft/planning

stages of monies released to Navajo Nation government. How the impact of pandemic, public health crisis and even loss loved ones, it's has been hard side for the people. The best we can do is develop business, road improvements, USA in all the 50 states, 567 tribes federal recognized tribes, lets listen to water development, internet/broadband, roads department, attending a work session. President Nez expressed to continue to work together and support the projects of Navajo Nation. Going forth, working together, teamwork, good words to share with leaders, open door imitative, establish good working relationships and have a leadership role to get projects done. RDC, the agriculture funds are approved and supported by RDC, he reported its insurance monies, just example. It's due to no rain which leaves the livestock's in dire need of feed and water. Agricultural Infrastructure Funds and the monitoring and implementation in the hands of chapter officials to ensure it's for those with livestock permits. He explained the math on 50/50 formula and funds on based on voter registration.
