



Upon her discussion with Auditor General, she was informed that if the activities warrant it, the Chapter can get assistance from the Tuba City ASC Office and/or request in writing for an audit. Therefore, a request was made to audit the Chapter's FMS beginning January of 2018 to current date. However, there has been no response from the NNAGO. The Chapter



Service Coordinator stated transaction regarding transferring funds was necessary and it was approved by Officials. Mr. Milford Maloney explained because of the uncertainties of the Pandemic, the Administration had to make decisions to transfer funds within the Accounts.
